1. Background:

LASOONA – Relief and Development Organization, in collaboration with the Initiative for Development & Empowerment Axis (IDEA) and with financial support from the START Network, is implementing the project "**Emergency Response to the Monsoon Floods in District Swat 2025**. This project aims to provide immediate relief and early recovery support to communities severely affected by the recent monsoon floods in Tehsils Babuzi, Matta, Khwazakhela, and Bahrain of District Swat. Many families have lost their homes, livelihoods, and access to clean water and food due to the floods.

To address these urgent needs, the project includes the distribution of essential relief items such as food packages, livestock feed (VANDA), Hygiene & MHM/Dignity Kits, Water Filtration Plants, Family Tents, Emergency Response Team Kits (ERT) For 1122, And ERT Kits For Community.

2. INTRODUCTION:

LASOONA-RELIEF AND DEVELOPMENT ORGANIZATION is a multi-disciplinary, development oriented and non-profit making organization. LASOONA affirms to be committed to well-being of masses through promoting ecologically sound development in remote and impoverished pockets of Pakistan in general and Khyber Pukhtoonkhwa (KP) in particular.

INITIATIVE FOR DEVELOPMENT & EMPOWERMENT AXIS (IDEA) is a non-profit organization registered under the Voluntary Social Welfare Agencies (Registration & Control) Ordinance 1961; in 2003, having registration # 2172.

START NETWORK is a global network of humanitarian organizations dedicated to transforming humanitarian action through preparedness, early action, and localization. Start network founded in 2010. It provided a platform bringing together over 80 nationals and international NGOs across the globe.

LASOONA – Relief and Development Organization is inviting quotations for the supply of food items, livestock feed (VANDA), HMM kits, water filtration plants, hygiene kits, tents, and Emergency Response Team (ERT) kits under the project titled "Emergency Response to the Monsoon Floods in District Swat 2025." LASOONA will lead the entire procurement process, including the evaluation and selection of suppliers, in close collaboration with IDEA. Following the selection, LASOONA and IDEA will jointly sign a formal agreement with the successful supplier, which will outline the total required quantities for both organizations. Based on this agreement, LASOONA and IDEA will issue separate purchase orders to the selected supplier according to their respective needs. However, all orders will follow the same unit prices, terms, and conditions as stipulated in the main contract. LASOONA invites signed and scanned quotations through www.ngostenders.com from suppliers, companies, firms, or dealers actively engaged in the business of the required items.

3. Packing/packaging & Branding Marking

Each kit/package must be properly packed in a suitable carton, toolbox, bag, or any other environmentally friendly material. Quoted prices must include the cost of printing LASOONA, IDEA, and donor logos, along with the project name, description, and safety instructions. These details should be printed or displayed in multiple colors on each pack, kit, or carton. The exact printing content and design will be finalized in consultation with the selected supplier and outlined in the agreement.

4. Expiry:

Food and other items where applicable, the supplier shall ensure a minimum remaining shelf life of [6] months from the date of delivery, unless otherwise agreed in writing. Any food items found to be expired or with less than [6] months' shelf life at the time of delivery will be rejected

5. Delivery Duty Paid (DDP)

"Delivery Duty Paid" means that the seller delivers the goods to the buyer, cleared them for import, and is not unloaded from any arriving means of transport at the named place of destination. The seller has to bear all the costs and risks involved in bringing the goods there including any "duty" (Which term includes the responsibility for and the risks of the carrying out of customs formalities and the payment of formalities, customs duties, taxes, and other charges).

6. Documents Required

Bidders must attach the signed and scanned documents on NGO Tender Portal. Bids can be rejected based on deficiencies in the documents.

- 6.1 A valid copy of Registration/License from the Chamber of Commerce
- 6.2 Fresh bank Statement of firm covering the last 02 months transactions
- 6.3 Ownership proof or Power of attorney for the person other than the real owner of the company
- 6.4 Proof of Similar supply or services to NGOs/INGOs/Govt. Department in the past. (LASOONA has the right to verify the previous supplier contracts or purchase orders)
- 6.5 Active and Valid Taxpayer, NTN number, and/or Valid Tax Exemption Certificate from FBR.
- 6.6 Quotation on prescribed format including all applicable taxes in PKR. All page of Quotation and Terms & Conditions must be signed and stamped by Vendors prior scanning.
- 6.7 Affidavit on the stamp paper (Original copy attested by a notary public) that company/firm has not been blacklisted by any Government or semi-Government departments or NGO/INGO.
- 6.8 The supplier will sign and submit all the attached annexures.
- 6.9 Lot-wise list of available stock.

7. Shortlisting and Bids Evaluation

Bids will be evaluated based on the technical and financial proposal with assigned percentages to each component as follows:

Technical Component = 30Marks (30% weightage) Financial Component = 70Marks (70% weightage)

Technical Component:

Similar services in the past 30Marks (Pls attach proof of relevant experience)

Financial Component:

The maximum number of points will be allotted to the lowest rate offered by the bidder. All other price proposals will receive points in inverse proportion to the lowest price; e.g., Lowest quoted price/Quoted price x 100= total marks obtained 70% of weightage.

Please note, the lowest quotation is not the sole criterion for the selection of bid, LASOONA will thoroughly check the organization's strength, quality of the sample, agreement with organizational policies and procedures, and terms and conditions of the tender. Quotation can be rejected on the basis of Low-quality sample.

8. Selection Criteria

Selection will be based on the following criteria:

- 8.1 Registered Relevant business
- 8.2 Relevant Experience with supplies
- 8.3 Agree with all terms and conditions of the Organization
- 8.4 Reasonable quoted rates within the approved budget
- 8.5 Quality of sample/satisfactory presentation

9. Sample Presentation

The shortlisted suppliers will be asked to dispatch/submit samples for the selected lot(s) items mentioned in the quotation form. Those who could not present their samples for whatever reasons on the preannounced date shall be excluded from further process. Samples will be evaluated in light of required specification mentioned in the tender Pack or tender form. The final selection will be done on the basis of sample quality specified in the tender documents.

10. Validity of the offer:

Quotations must be valid for at least thirty-days period. The validity period can be extended on the mutual consent of both parties.

11. Security Deposit:

All interested vendors will have to submit a call deposit @ 2.5 percent of the total quoted rate of the respective lot/lots in the name of LASOONA. Call deposits must be made/withdrawn against the supplier business account only. In case the bidder failed to provide the CDR within stipulated time, will be excluded from further process. Call deposits of selected suppliers will be released upon request from the contractor and approved by competent authorities on the expiry of the contract and/or successful completion of supply/services.

12. Taxes:

Quotations must be inclusive of all applicable taxes present and imposed during the contract implementation. The firm claims to be tax exempt must provide an authentic tax exemption certificate from FBR. Taxes should be included in quoted prices and need not mention separately. Quotations mentioning taxes separately will not be considered.

13. Final documents

The following documents shall be provided with each payment.

- 1. Copy of purchase Order issued by LASOONA and IDEA
- 2. Invoices/Claims Form Issued by Vendors on the name of LASOONA and IDEA
- 3. GRN issued by LASOONA and IDEA

14. Payment modalities:

Payment will be made in one installment upon 100% completion of the supply as per the Purchase Order. It will be processed via crossed cheque or online transfer within one week of submission of complete claim documents to LASOONA/IDEA. Each organization will release payment according to issued PO and quantities received as per GRN. All applicable taxes will be deducted in accordance with government regulations.

15. Penalties

- 15.1 If, in any case, the selected bidder is not willing to sign the contract for whatever reasons, the company will be penalized by forfeiting the 50% amount of the call deposit money.
- 15.2 In case after signing the contract, the supplier is not willing to start supplying on the quoted prices and all terms and conditions of tender documents, the supplier contract will be terminated and 100% of the call deposit will be forfeited.
- 15.3 If the Supplier provided low-quality items/goods, the supplier will be bound to replace the items at his own cost within a week otherwise his contract will be canceled, and 100% of

- the call deposit will be forfeited.
- 15.4 In the event of delay in the completion of work caused other than by force majeure, the client (LASOONA) is entitled to make use of a penalty of 5/1000 (Five per thousand) per day of the total value of the agreed amount based on Purchase Order issued from the office of the competent authority. The penalty will be deducted from either the call deposit or invoice.

16. Other Conditions

- 16.1 Bids shall be made in writing calculated in PKR only and clearly stated in the appropriate format
- 16.2 The award of the contract will be made within 3 days subject to approval from donor.
- 16.3 No allowance for the preparation of tender documents is permissible and no TA/DA will be paid for, Office Visits, site visit or any other visit in this regard.
- 16.4 Bidders can apply for all lots and a lot of their choice having relevant experience. While rates must be quoted for all items within selected lot(s). In-case of bidding for a selected lot/lots, the bidders are required to submit CDR for each lot separately.
- 16.5 Quantities are subject to alteration. LASOONA/IDEA reserves the right to award the contract of all lots to one bidder or divide them among different bidders.
- 16.6 Part of the tender or tender as a whole can be canceled without assigning any reasons.
- 16.7 LASOONA/IDEA reserves the right to regret/reject any offer without transmitting any reason.
- 16.8 Bidders must quote price as per attach format.
- 16.9 Only short-listed bidders will be contacted for the final interview meeting
- 16.10 All Scanned documents submitted for tender processing shall be retained by LASOONA/IDEA for future record and the tenderer have no right to have their tenders returned to them. LASOONA/IDEA can ask vendors to submit original documents for verification.
- 16.11 LASOONA/IDEA are not liable for any damage to the applicant's person or property during processing the tender if something should occur.
- 16.12 All required documents must be scanned and attached with financial bid, or the application will be disqualified.
- 16.13 Hard documents are not acceptable.
- 16.14 The Procurement Committee will check the tenders to ensure that they contain no amendment to the terms or any other (calculation) errors, in case there is any calculation mistake, the unit price will be considered as a base for the correction, to assist in the examination, evaluation, and comparison of bids, the Tender Committee may, at its discretion, request clarification from the LASOONA/IDEA staff or Bidders.
- 16.15 Suppliers who do not receive written feedback within 15 working days after the expiry of the Invitation for Tender (IFT) deadline shall consider themselves unsuccessful.
- 16.16 LASOONA/IDEA will verify/check/inspect all the items before and after the delivery (Pre and Post Shipment).
- 16.17 By submitting a tender, the tenderer fully and unconditionally agrees to all terms of the tender, giving up any of their own sales conditions. They must carefully read and follow all instructions, forms, contract provisions, and technical requirements included in the tender documents.
- 16.18 Collusion between the firms is strictly prohibited. Any firm/group of firms found involved in creating a cartel or any other collusion arrangement against the interest of the project, will be blacklisted and debarred.
- 16.19 The Supplier must quote only one option for each item. Bids received with more than one options and rates will be rejected.
- 16.20 LASOONA/IDEA guarantees that all procurement activities are fully and transparently documented for internal or donor audit purposes. LASOONA guarantees confidentiality of the procurement process.
